# **Bond Status:**

No bonds issued yet, intend to issue \$40-50M in bonds Fall 2023.

### Comments/Closing:

- Question raised about the construction management process, Matt Herzog, Project Advocates explained:
  - Construction Manager at Risk (CMAR) will be retained per state statute and board policy. This
    process will start in late 2023.
  - Design Advisory Committees have been formed on the five current projects.
  - Ed Specs originally created in Phase I, were updated over the Summer 2023.
  - Request for Ed Specs document be shared with committee These were emailed 9-12-23.
- Question raised about the anticipated Westside Foundation's project at Westside High School.
  - Details will be released to the public at VIVI in October 2023.
