- Adam Yale, Westside School Board member discussed the importance of the upcoming levy override vote
 - This is not a tax increase.
 - Asking to keep the current authority on the books for another 5 year extension. Which has been in place the past 25 years.
 - Vote allows an additional 0.15% levy. However, the district has not asked for the whole amount in years past.
 - The Westside District is equitable to our peer size districts.
 - The levy override is critical to Westside Community Schools
 - Allows District to operate 10 elementary schools instead of seven
 - Competitive teacher compensation to retain our best teachers
 - EY, AP/dual enrollment classes, multiple foreign languages, elementary strings, modular schedule
 - 1:1 Technology
 - Robust and individualized special services
 - This is a political campaign every 5 years needs to be brought in front of the voters
 - Ballots mailed out September 20th and need returned by October 12th.
 - Returned through mail
 - Dropped in Douglas County Election Boxes
 - Ballot collection during school pickup lines
- Principals report
 - Collaboration night low turn out
 - Usually provide childcare and food but unable due to covid protocols
 - Future years, hope to provide those options
