- **President's Report:**
 - Gator of the Month upcoming
 - Potentially start date for Green is the 17th
 - 14th and 18th School picture day, but will be changed to the 18th if Green
 - 21st will be professional dev day
 - October 15th is Parent Teacher communication
 - Tables in Garden Area have arrived from Grant
 - Not be available in garden area right now due to being 1 exit and not 2
 - \$250 Grant by Brooke Dowse was approved
 - West Hills donation for schools supplies
 - Very proud of both teachers and parents for virtual work, only 15 not engaging
- **Treasurer Report**
 - Provide overview on balance and deposits
- **Liability Insurance:**
 - Jessica turned in forms and will be quoted on total fees to either accept or reject
- Gator Store has been put up and have a week left for orders
- Gaga Pit parts have been ordered and will arrive in a couple weeks
 - Once we get approval we will be able to put up in a weekend
 - Mrs. Moon confirmed other schools are using theirs, but need to limit
 - Won't be able to do a big unveiling until a later time
- **New Business:**
 - Fundraising is new topic
 - POP! Presentation Feedback
 - One of the concerns is the % of raised money would be similar even with a doubling of incoming revenue
 - COVID brings challenges to the options for fundraising
 - If we do Read-a-thon on our own, we need bigger carrots to push engagement
 - Maybe look for donations from outside sources to help
 - Projections show potential \$5K in money for CC and additional \$2K for kids
 - **Action Item:** Read-a-thon in the fall and do POP! Fundraising and event in the spring. Then do fun run and carnival as usual.
 - Having the read-a-thon after Halloween, but before Thanksgiving may be a sweet spot

- Potentially sourcing water bottles from a couple different places
 - Need to make sure the companies can support
- Continue with Don and Milly's fundraising option, but need to promote on Facebook and Dojo
 - Mrs. Moon to validate if it can be promoted, feels like it should be okay, but confirming
- Potentially reaching out to 402 BBQ as they now have a brick and mortar location
- Also talked to Jenna at Scooters about possibly joining, wanted to know about % and Jessica will get back with 10-20%
 - Scooters may be willing to do 30% and possibly a weekday to get more business
 - Decision: Looking at Wednesday, 1st of the month
- Amazon Smile and TAG Update
 - Can't do Amazon Smile since we are tax exempt, but Westside Foundation does
 - Continue to promote TAG
- Conferences will look different, Mrs. Moon will get back to CC with more information on how we can support teachers
- **Action Item:** RAZ Kids annual fee is due, Should we approve \$900 fee? Approved by CC
