Board of Education Meeting Minutes ~ February 3, 2025

The Board of Education of School District 66 was convened in an open and public session on February 3, 2025, at 6:00 p.m. at the District Administration Office, 909 S. 76th St., Omaha, Nebraska.

Notice of the meeting was given by placing advance notice on the front page of the District's website no less than 48 hours in advance of the scheduled commencement of the meeting as authorized by Board Policy 1220. Notice for this meeting appeared beginning on January 14, 2025, and appeared continuously up through the start of this board meeting. Notice of the meeting was also published in the Daily Record on January 31 and February 3, 2025, and on their website at omahadailyrecord.com, as well as the NE Press Association website at nepublicnotices.com. Notice of this meeting and the availability of the agenda was simultaneously given to all members of the Board of Education and available to anyone at the Board of Education office. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Ms. Blakely called the Board of Education Meeting to order at 6:01 p.m. She welcomed those in attendance and confirmed with Ms. Hurley that public notice had been given of the meeting under the Nebraska Open Meetings Act and that a copy of the Nebraska Open Meetings Act was posted at the meeting and on the district website, as required by law. She acknowledged that the meeting had been publicly announced and the agenda was available to any interested parties. Board Meeting attendance is noted above. The Pledge of Allegiance was recited.

Approval of Minutes

Ms. Blakely requested a motion for approval of the minutes from the Board of Education Meeting held on January 13, 2025. Ms. Karnes moved for approval; Ms. Morrissette seconded. Motion carried by unanimous roll call vote.

Communications

Last week - the week of January 27-31, 2025 - the NE Association of School Boards celebrated School Board Appreciation week across the state. Since we did not have a board meeting last week, Ms. Elizabeth Power, Director of Communications and Engagement, welcomed a number of staff and students who were

on hand to present our board members with gifts of appreciation and to recognize their hard work and dedication on behalf of Westside Community Schools.

Academic Report: WMS Math 8

Ms. Kim De La Cruz, Director of Secondary Teaching and Learning, welcomed Westside Middle School Math Teachers, Ms. Faren Huben, Ms. Lisa Butler, and Ms. Bailey Harriger, who presented an informational report to the Board on PreAlgebra 8 - a course that is taken by a majority of students at WMS. They reviewed the most essential unit of PreAlgebra 8 (Solving Multi-Step Equations), which covers the skills needed for success in 9th grade algebra as well as the expectations required for MAP testing (Measures of Academic Progress) and NSCAS state assessments (NE Student-Centered Assessment System). Instruction of this unit took place during the first semester, in September and October. A copy of the Executive Summary and slide presentation are included in the board documents folder.

Phase II Bond Project: Westbrook Elementary - Approval of Abatement Bid

Mr. Matt Herzog, Project Advocates, requested approval of the bid from Jamco Abatement Services, Inc. in the amount of \$59,840 for abatement work at Westbrook Elementary. The Phase II Bond work at Westbrook, which includes renovation of the exterior facade, HVAC system and accessibility upgrades, requires the abatement of asbestos containing materials (ACM). Jamco submitted the lowest qualified bid for this work, which will be completed during the summer months when the school will be unoccupied. Ms. Morrissette moved for approval; Dr. Van Gelder seconded. Motion carried by unanimous roll call vote. Copies of the Executive Summary and Abatement Bid Package are included in the board documents folder.

Approval of WHS Theater Lighting and Rigging Bid

Mr. Andy Wane, Director of Facilities, requested approval of the bid from Downs Electric in the amount of \$619,554 for new rigging and lighting in the Westside High School Auditorium. Modifications were made to the original scope of the project (budgeted at \$500,000) when additional issues were identified that will be addressed during the completion of this work (replacement of the fire curtain; customization of stage rigging, due to angled walls on the stage; repair of smoke vents above the stage). Dr. Van Gelder moved for approval; Ms. Rider seconded. Motion carried by unanimous roll call vote. Copies of the Executive Summary and bid documents are included in the board documents folder.

Board Policies for Approval (#5470 and #5680)

Mr. Nick Lesiak, In-House Legal Counsel, requested approval of minor language revisions to policies #5470 and #5680. Both policies were previously presented for discussion and consideration at the Board Meeting on January 13, 2025.

<u>Policy #5470 - School-Sponsored Publications, Productions and Activities</u>: Mr. Yale moved for approval; Ms. Rider seconded. Motion carried by unanimous roll call vote.

<u>Policy #5680 - Student Insurance:</u> Ms. Karnes moved for approval; Mr. Yale seconded. Motion carried by unanimous roll call vote.

Board Policies for Review (#2214 - Title IX)

Mr. Lesiak presented policy 2214 for discussion. On January 9, 2025, a U.S. District Court in Kentucky vacated the 2024 Title IX revisions promulgated by former President Biden's Department of Education, which the district adopted in September 2024. Now that President Trump has been inaugurated, it is unlikely the DOE will challenge this ruling. As a result, the 2024 revisions go away, and we return to the 2020 version of the Title IX regulations, which the District originally adopted in November 2020. Mr. Lesiak will present policy #2214 again for approval at the Board of Education Meeting on February 18, 2025. A copy of the Executive Summary and the 2020 version of policy 2214 are included in the board documents folder.

Personnel Report: Employment Actions Related to the Contracts of Certified Staff Members

Dr. Andrea Haynes, Assistant Superintendent of Human Resources and District Operations, presented the personnel report (one certified staff probationary contract; four certified staff resignations) for board approval. Mr. Yale moved for approval; Ms. Karnes seconded. Motion carried by unanimous roll call vote. A copy of the personnel report is included in the board documents folder.


