# Board of Education Meeting ~ February 6, 2023

The Board of Education of School District 66 was convened in an open and public session on February 6, 2023, at 6:00 p.m. at the District Administration Office - ABC Building - 909 S. 76th Street, Omaha, Nebraska.

Notice of the meeting was given by placing advance notice on the front page of the District's website no less than 48 hours in advance of the scheduled commencement of the meeting as authorized by Board Policy 1220. Dr. Van Gelder called the Board of Education Meeting to order at 6:00 p.m. She welcomed those in attendance and confirmed with Ms. Hurley that public notice had been given of the meeting under the Nebraska Open Meetings Act and that a copy of the Nebraska Open Meetings Act was posted at the meeting and on the district website, as required by law. She acknowledged that the meeting had been publicly announced and the agenda was available to any interested parties. Board member attendance is noted above. Dr. Van Gelder requested a motion for an excused absence for Doug Krenzer. Ms. Blakely moved for approval; Ms. Karnes seconded. Motion carried by unanimous roll call vote. The Pledge of Allegiance was recited.

#### Communications

Ms. Brandi Paul, Director of Communications and Community Engagement, had the privilege of welcoming many, many guests this evening (principals, students and families) who were all in attendance to help recognize our amazing board members! # Nebraska Student-Centered Assessment System (NSCAS) Testing Data Report

Dr. Mark Weichel, Assistant Superintendent for Teaching and Learning, presented an overview of NSCAS testing results. Dr. Weichel advised the board that, while on-going changes with the NSCAS assessment since 2019 have made it difficult to compare year-over-year NSCAS scores, the spring 2022 NSCAS results reflect growth in a number of areas. He shared that our building leaders and teachers also rely on MAP (Measures of Academic Progress) testing results as well as consistent and regular analysis of achievement data to determine how our students are learning and progressing. Strength areas include 4th, 5th and 6th grade ELA (English Language Arts), and 6th and 8th grade Math. Dr. Weichel outlined the district's renewed focus on learning results with the Instructional Model Principles of: 1) Positive Classroom Climate; 2) Effective Classroom Management; 3) Data-Informed Instructional Practices; and 4) Active Student Engagement. He also advised the board that, at the middle school, a math interventionist is being added, along with extra ELA core content instructional time; and after-school tutoring programs will be piloted at both Westbrook and Westgate Elementary schools. Dr. Weichel's Executive Summary and keynote presentation are included in the board documents folder.

#### Science of Reading

Dr. Kelcy Tapp, Director of Elementary Teaching and Learning, presented an informational report to the Board on the Science of Reading. Current English Language Arts (ELA State Standards) standards that were approved by the NE State Board of Education in September 2021 included the implementation of Foundational Skills and the Science of Reading. Dr. Tapp advised the board that the District has been educating teachers and implementing Science of Reading practices over the past six years. The District's adoption of new ELA curriculum materials in the fall of 2023 will include Foundational Skills materials and will more fully align with Science-based literacy instruction. Dr. Tapp shared the research of Science-based literacy instruction and the importance of integrating reading and writing in all content areas; what to teach to ensure fluency in reading and writing; and how to teach, using explicit and structured instruction. # **Board Policies for Approval**

The following policies were brought to the Board for discussion and consideration at the Board of Education Meeting on January 17, 2023, and are being presented this evening for approval:

#5230 - Graduation: Class of 2025 and beyond (Students): Minor revision to course requirements for "Business, Computer Science and Technology" due to the *Computer Science and Technology Education Act* that was passed by the Nebraska Legislature in the spring of 2022. Ms. Kim De La Cruz, Director of Secondary Teaching and Learning, requested approval of this revision. Ms. Karnes moved for approval; Ms. Morrissette seconded. Motion carried by roll call vote.

Mr. Nick Lesiak, District In-House Legal Counsel, presented the following two new policies for approval:

#3460 - Data Breach Response (Business): New policy to establish and ensure compliance with state and federal laws in the event of a data breach. Mr. Yale moved for approval; Ms. Blakely seconded. Motion carried by roll call vote.

#7110 - Sponsor Recognition (Community Relations): New policy to permit sponsor recognition on a limited basis. Ms. Blakely moved for approval; Ms. Karnes seconded. Motion carried by roll call vote.

Mr. Lesiak presented revisions to the following two existing policies for board discussion and consideration: #3120 - Depository for All School Funds (Business) and #3250 - Insurance (Business). # **Personnel Report**

Dr. Haynes presented the personnel report (seven certified staff probationary contracts; seven certified staff resignations; one non-approval of certified staff resignation) for board approval. Ms. Morrissette moved for approval; Ms. Blakely seconded. Motion carried by unanimous roll call vote. A copy of the Personnel Report is included in the board documents folder.

# **Board Member Representation / Legislative Updates**

Board members were represented at a number of events over the past three weeks including building walk-throughs and school visits; the Westside Swim & Dive Invitational January 28-29; the Show Choir Competition of Excellence January 28th; and the Anne Frank Traveling Exhibit Open House on January 30th. Ms. Morrissette has been participating in weekly Zoom calls with the NASB Legislative Committee and also attended (along with Dr. Lucas) the NASB Legislative Issues Conference on January 23, 2023, in Lincoln. Last week, Dr. Lucas provided legislative testimony in support of LB324 (Special Education Funding) and LB385 (Teacher Retention).
