Ms. Karnes called the Board of Education Meeting to order at 6:31 p.m. She welcomed those in attendance and confirmed with Ms. Hurley that public notice had been given of the meeting under the Nebraska Open Meetings Act and that a copy of the Nebraska Open Meetings Act was posted at the meeting and on the district website, as required by law. Review of Tentative Summer (2021) Facilities Projects

Mr. Russ Olsen, Director of Facilities, presented an overview of current and planned facility projects that were identified on the district's 2019 long-range (10-year) facility planning matrix. District-wide projects scheduled for completion (or already completed) in FY21 include security upgrades, interior flooring upgrades, concrete repair, window coverings, parking-lot striping, large painting projects, and

tree/landscaping services (tree removal or planting). Some projects that have already been completed include the replacement of the chiller at West Campus; Westbrook ECC parking lot replacement; and demolition of the Mitchell House on the west side of the high school (to make way for an additional parking lot). Summer '21 roofing projects include the WHS Science wing and WMS cafeteria. Copies of the Executive Summary and keynote presentation are attached to the official minutes.

Student Wellness Annual Report (Board Policy #5660)

Dr. Mark Weichel, Assistant Superintendent for Teaching and Learning, presented an overview of district student wellness initiatives and activities in the 2020-2021 school year, per board policy 5660. The six goals outlined in policy 5660 include: Health and Nutrition Education; Physical Activities and Education; School-Based Activities to Promote Student Wellness; Nutrition Services; Counseling, Psychological, and Health/Social Services; and Safe-School Environment. Board Member Representation / Legislative Updates

The district celebrated the opening of the Merrill "Swede" Carlson Golf Training Center at Westside High School yesterday. Funded entirely through donations to the Westside Foundation, members of the Carlson family were on hand to dedicate the facility, which features a state-of-the-art golf training simulator. Not only will the Swede Center provide access for year-round training for the boys and girls golf teams, it will also offer opportunities for community outreach and a way to introduce students to the game of golf. Dr. Lucas and Mr. Krenzer will join our district lobbyist, Mr. Sean Kelley, in Lincoln on February 23rd to provide testimony in opposition to LB651.
