Ms. Karnes called the Board of Education Meeting to order at 6:30 p.m. She welcomed those in attendance and confirmed with Ms. Hurley that public notice had been given of the meeting under the Nebraska Open Meetings Act and that a copy of the Nebraska Open Meetings Act was posted at the meeting and on the district website, as required by law. Mr. Lesiak advised that revisions include the shifting of some content from policy 1120 to policy 1000, addition of clarifying language regarding the six primary functions of the board, and ensuring that all state statute requirements pertaining to board functions are included in policy.
