Board of Education Meeting Minutes ~ March 4, 2024

The Board of Education of School District 66 was convened in an open and public session on March 4, 2024, at 6:00 p.m. at the District Administration Office - ABC Building - 909 S. 76th Street, Omaha, Nebraska.

Notice of the meeting was given by placing advance notice on the front page of the District's website no less than 48 hours in advance of the scheduled commencement of the meeting as authorized by Board Policy 1220. Ms. Morrissette called the Board of Education Meeting to order at 6:02 p.m. She welcomed those in attendance and confirmed with Ms. Hurley that public notice had been given of the meeting under the Nebraska Open Meetings Act and that a copy of the Nebraska Open Meetings Act was posted at the meeting and on the district website, as required by law. She acknowledged that the meeting had been publicly announced and the agenda was available to any interested parties. Board Meeting attendance is noted above. The Pledge of Allegiance was recited.

Approval of Minutes

Ms. Morrissette requested a motion for approval of the minutes from the Board of Education Meeting held on February 20, 2024. Mr. Yale moved for approval; Ms. Blakely seconded. Communications

Ms. Elizabeth Power, Director of Communications and Engagement, advised the Board on recent and upcoming mailings, including the District's Annual Report that was received at all households in the District this past week, and postcard reminders that will be sent to families at Hillside, Westgate and the Middle School in the coming weeks regarding construction kick-off meetings that will be held in May. These meetings will inform families of the construction timeline for Phase II projects. Ms. Power's office has also been assisting the high school with frequent communication to students and families regarding the start of construction on the WHS Life Complex and the subsequent loss of the south parking lot. Alternate parking started today (March 4th) and high school and district administrators were on hand at various parking areas this morning to assist with student parking and drop-off.

Academic Report: Middle School Science 8

As part of the Teaching and Learning team's year-long series on academic achievement, Mr. Mark Durante, WMS Science Teacher, shared information on what their department identified as the most essential concept that is foundational for success in Science 8. The concept of "Claim, Evidence, and Reasoning" (CER) is the basis for strong critical thinking skills. In Science 8, CER is best showcased with the Genetics and Heredity unit, which students are currently working on. Mr. Durante shared examples of leading questions for classroom discussions and results of assessments - both before and after reteaching. Because CER is critical for student success, it is a concept that is present across the curriculum. Copies of the Executive Summary and powerpoint presentation are included in the board documents folder.

Phase II Bond: Approval of Design Development for Hillside Elementary

Mr. Matt Herzog from Project Advocates, along with Mr. Todd Moeller, Ms. Nancy Novak, and Mr. Rick Hauptman from Alley Poyner Macchietto Architecture (APMA), presented the Design Development for the new Hillside Elementary for board approval. Since approving the Concept Design on October 17, 2023, APMA has continued to work closely with the Hillside DAC and District staff to create the Design Development package being presented for approval. Construction is scheduled to begin in June 2024. Staff and students will remain in the current building during construction. The Board of Education had the opportunity to preview the Design Development at a meeting with Project Advocates and APMA on March 1, 2024. Ms. Karnes moved for approval; Dr. Van Gelder seconded. District Enrollment and Demographics Report - 2023-2024 School Year

Mr. Robert Aranda, Director of Student Services, presented an overview of the enrollment and demographic report for the 2023-2024 school year. K-12 enrollment for this school year increased .69%, with 6,165 K-12 students. English Language Learner enrollment rose slightly over last year, with ELL students making up 4.04% of total enrollment. Ethnic group student population that grew include Hispanic (from 11.27% to 12.23%) and Black/African American (from 9.31% to 9.80%). Students eligible for Special Education services also rose slightly, from 14.34% to 15.34%.
