Board of Education Meeting Minutes ~ April 9, 2025

The Board of Education of School District 66 was convened in an open and public session on April 9, 2025, at 12:15 p.m. at the District Administration Office, 909 S. 76th St., Omaha, Nebraska.

Notice of the meeting was given by placing advance notice on the front page of the District's website no less than 48 hours in advance of the scheduled commencement of the meeting as authorized by Board Policy 1220. Notice for this meeting appeared beginning on March 25, 2025, and appeared continuously up through the start of this board meeting. He acknowledged that the meeting had been publicly announced and the agenda was available to any interested parties. Board Meeting attendance is noted above. 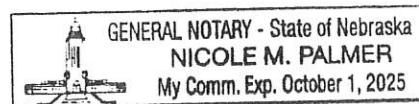



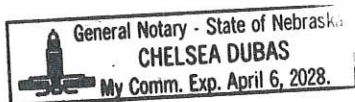
