# Board of Education Meeting Minutes ~ July 19, 2021

The Board of Education of School District 66 was convened in an open and public session on July 19, 2021, at 5:00 p.m. at the District Administration Office - ABC Building - 909 S. 76th Street, Omaha, Nebraska.

Notice of the meeting was given by placing advance notice on the front page of the District's website no less than 48 hours in advance of the scheduled commencement of the meeting as authorized by Board Policy 1220. Notice for this meeting appeared beginning on June 29, 2021, and appeared continuously up through the start of this board meeting. Notice of the meeting was also published in the Daily Record on July 16 and 19, 2021, and on their website. Copies of proof of publication are attached to the official minutes. Notice of this meeting and the availability of the agenda was simultaneously given to all members of the Board of Education and available to anyone at the Board of Education office. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Mr. Krenzer called the Board of Education Meeting to order at 5:00 p.m. He welcomed those in attendance and confirmed with Ms. Hurley that public notice had been given of the meeting under the Nebraska Open Meetings Act and that a copy of the Nebraska Open Meetings Act was posted at the meeting and on the district website, as required by law. He acknowledged that the meeting had been publicly announced and the agenda was available to any interested parties. Board member attendance is noted above. The Pledge of Allegiance was recited.

# **Approval of Minutes**

Mr. Krenzer requested a motion for approval of minutes from the June 29, 2021, Board of Education Meeting. Ms. Morrissette moved for approval; Ms. Karnes seconded. Motion carried by roll call vote.

#### **Financials**

Ms. Morrissette presented the treasurer's report for June 2021, and requested approval for expenditures in the amount of \$10,347,412; Ms. Karnes seconded. Approval of expenditures was passed by unanimous roll call vote. Copies of the June 2021 financial reports (financial statements,

general fund disbursement summary and general fund check register) are included in the board documents folder.

#### Communications

<u>Public Comment:</u> There were no requests for Public Comment.

Awards and Honors: Ms. Brandi Paul, Director of Communications, recognized three staff members from Westside Middle School for their recent awards: Ms. Kristeen Shabram, Business Teacher, honored with the 2021 Communication and Information Systems Career Field Richard Katt Outstanding Nebraska Career Educator Award; and Ms. Abbey Painter, Speech Language Pathologist, and Ms. Faren Huben, Math Teacher, both were honored by *Edficiency* for their excellence in using flexible instructional time. Ms. Huben received the Excellence in Flex Time Award; Ms. Painter received an Honorable Mention. Ms. Paul also recognized WMS Assistant Principal, Brian Stevens, who was credited by Ms. Painter for providing outstanding leadership and commitment to middle school staff. Ms. Paul also highlighted former WHS student, 2019 graduate Ms. Eva Houston, who will represent Team USA in wheelchair racing at the 2021 Paralympic Games in Tokyo. Finally, the WHS Boys Summer Legion Baseball Team will be hosting the 2021 State Legion Tournament next week.

# Review of State Aid - FY22

Mr. Brian Gabrial, District Officer of Business and Finance, presented the annual state aid review, including an overview of the state aid funding formula and the district's needs and resource components. Because of a bill that was introduced in the last legislative session (LB651) that calls for the termination of the State's enrollment option program for public schools (and thus ending net option funding), Mr. Gabrial explained that - should LB651 pass - the District could potentially lose \$20 million in state aid. Copies of Mr. Gabrial's Executive Summary and keynote presentation are included in the board documents folder.

# Review of Non-Levy Funds - FY22

Mr. Gabrial provided a timeline of the FY22 budget adoption process, and an overview of preliminary budgeted expenses in non-levy funds: Nutrition Services, Activities, Enterprise, and Student Fees. Mr. Gabrial reported that total budgeted expenses in the non-levy funds for FY22 (\$8,872,826) represents a 1.46% decrease (\$131,508) from FY21 (\$9,004,334). Copies of Mr. Gabrial's Executive Summary and keynote presentation are included in the board documents folder.

# **Levy Override Resolution**

Dr. Mike Lucas presented the resolution to hold a Levy Override Election in the fall of 2021 that would become effective for the 2023-2024 fiscal year and run through the 2027-2028 fiscal year. The election would ask voters to override the state imposed levy limit of \$1.05 and maintain the current levy limit at \$1.20. Dr. Lucas stated that this is not a tax increase, but rather an extension of what voters approved in 2017. And even though the district has had the taxing authority in place for 25 years, the district and the Board of Education have worked hard to tax less than what voters have approved.

The general fund tax request for 2021-2022 (to be set in September 2021) will see a decrease for the third year in a row, likely to be less than \$1.17. Dr. Lucas shared that the levy override is intended to support general operations in our schools, including:

- Operating and maintaining 10 neighborhood elementary schools
- Recruiting / retaining high-quality staff
- 1:1 technology for all students (a distinct advantage for our students and staff during the pandemic)
- Operation of the districts award-winning special services programming
- Providing strong academic programming from Pre-K through 12th grade

Ms. Blakely moved for approval; Dr. Van Gelder seconded. Copies of the Executive Summary, motion, resolution and ballot language are included in the board documents folder.

# Sale of District Equipment

Mr. Russ Olsen, Director of Facilities, requested board approval (per policy #3450) for the sale of timing equipment used by the high school for swim meets. The Colorado Time System equipment would be sold to Ralston High School. Westside High School replaced the timing equipment last year with a new Daktronics system. Ms. Morrissette moved for approval; Ms. Blakely seconded. Motion carried by unanimous roll call vote. A copy of the Executive Summary is included in the board documents folder.

#### Board Policies for Approval (Second Reading)

Mr. Nick Lesiak, District In-House Legal Counsel, presented two separate recommendations for the following board policies (both were presented for first reading on June 14, 2021):

Policy #1505 - Participation in Insurance Program by Board Members - existing policy recommended for elimination since it does not apply to the circumstances of the District's insurance plan. Mr. Yale moved for approval for elimination of policy 1505; Ms. Karnes seconded. Motion carried by unanimous roll call vote.

Policy #7105 - Anti-Hate Activities Policy - new policy recommended for approval to further establish the District's commitment and responsibility to anti-hate bias at the highest level. Dr. VanGelder moved for approval of policy 7105; Ms. Blakely seconded. Motion carried by unanimous roll call vote.

Copies of the Executive Summaries and each policy are included in the board documents folder.

# Approval of District Strategic Plan

Dr. Lucas presented the District Strategic Plan for the five year period 2021 through 2026 for board approval. He expressed his appreciation to Dr. Mark Weichel, Assistant Superintendent for Teaching and Learning. Dr. Weichel, who was unable to be in attendance at tonight's meeting, led the Strategic Plan Renewal with Dr. Matt Lee, District Coordinator of Technology Integration.

In early 2021, they led numerous rounds of focus group meetings with a number of district stakeholder groups, including students, staff, parents, community members, business leaders and post-secondary institutions. The input from these groups was examined by the Strategic Plan committee and a first draft was formulated. Dr.'s Weichel and Lee took the draft back to the focus groups for additional feedback. Final drafts of the Strategic Plan document were finalized in May and June. District leaders will share the Strategic Plan with all staff when they return on August 9th. Board members expressed their appreciation for the collaborative nature of the process and the numerous opportunities for feedback and input from all stakeholders. Dr. Van Gelder moved for approval of the District's Strategic Plan; Ms. Karnes seconded. Motion carried by unanimous roll call vote. Copies of the Executive Summaries and the Strategic Plan are included in the board documents folder.

## **Personnel Report**

Dr. Andrea Haynes, Assistant Superintendent for Human Resources and District Operations, presented the personnel report (recommendation of two certified staff probationary contracts; recommendation for non-approval of one certified staff resignation) for board approval. Ms. Karnes moved for approval; Mr. Yale seconded. Motion carried by unanimous roll call vote. A copy of the Personnel Report is included in the board documents folder.

Ms. Morrissette attended a recent NASB Legislative Committee Meeting. Dr. Lucas, along with the District's lobbyist Mr. Sean Kelley, is meeting with Sen. LouAnn Linehan later this week.
