#### Board of Education FY22 Budget Amendment Public Hearing Minutes ~ August 15, 2022

A Public Hearing for a 2021-2022 Budget Amendment for Westside Community Schools, School District 66, was convened by the Board of Education in open and public session on August 15, 2022, at 5:00 p.m., at the District Administration Office - ABC Building - 909 S. 76th Street, Omaha, Nebraska.

Notice of the public hearing was given in advance by publication in *The Daily Record* and appeared August 12 and 15, 2022, a copy of which is attached to the official minutes. Notice of the public hearing was also posted on the district website beginning on July 19, 2022. Notice of this public hearing and the availability of the agenda was simultaneously given to all members of the Board of Education and available to anyone at the Board of Education offices. All proceedings hereafter shown were taken while the convened public hearing was open to the attendance of the public.

Dr. Van Gelder called the Public Hearing to order at 5:00 p.m. She welcomed the audience and confirmed with Ms. Hurley that public notice had been given of the meeting under the Nebraska Open Meetings Act, and that a copy of the Nebraska Open Meetings Act was posted at the meeting, as required by law. She acknowledged that the meeting had been publicly announced and the agenda and supporting documents dealing with issues being discussed during the public hearing were available. Board member attendance is noted above; Dr. Van Gelder requested a motion for an excused absence for Doug Krenzer. Ms. Morrissette moved for approval; Mr. Yale seconded. Motion carried by unanimous roll call vote.

Dr. Van Gelder stated that the purpose of the Public Hearing was to hear support, opposition, or observations relating to the proposed budget amendment(s) for the 2021-2022 fiscal year for School District 66.

Mr. Brian Gabrial, District Officer of Business and Finance, reported that, as a result of closing costs paid in FY22 for future refinancing of bonds, budgeted disbursements and transfers are increased by \$254,972.24 in the Bond Fund. In the Nutrition Services Fund, budgeted disbursements and transfers are increased by \$1,017,491 due to increased participation in the school lunch program.

Mr. Gabrial advised the board that neither of these adjustments to the FY22 budget require a change to the District's FY22 tax rates. Board approval of these adjustments will be sought at the regular Board of Education Meeting immediately following this public hearing.
