Board of Education Meeting Minutes ~ August 12, 2021

The Board of Education of School District 66 was convened in an open and public session on August 12, 2021, at 11:00 a.m. at the District Administration Office - ABC Building - 909 S. 76th Street, Omaha, Nebraska.

Mr. Krenzer called the Board of Education Meeting to order at 11:02 a.m. He welcomed those in attendance and confirmed with Ms. Hurley that public notice had been given of the meeting under the Nebraska Open Meetings Act and that a copy of the Nebraska Open Meetings Act was posted at the meeting and on the district website, as required by law. He acknowledged that the meeting had been publicly announced and the agenda was available to any interested parties. Board member attendance is noted above. 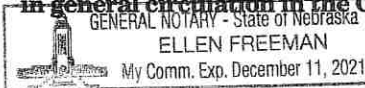
